

**OAKLAND UNIFIED SCHOOL DISTRICT  
MEASURE G AND MEASURE N - PARCEL TAX EXEMPTION APPLICATION | 2016-17 TAX YEAR**

The purpose of this form is to determine if you qualify for an exemption to the Measure G or Measure N Parcel Tax for 2016-17. You must reside in the single family residential unit and must either (1) have an income below a certain level or (2) be age 65 or older. If you believe you will qualify under either exemption, please return a completed application, verification of residence and age or income to: Oakland Unified School District, c/o Parcel Tax Information Desk, 1000 Broadway, Suite 450, Oakland, CA 94607, by **July 15, 2016**. **Late application forms cannot be processed for exemption but will be returned; they can be resubmitted with a copy of your 2016-17 Property Tax Statement for a refund.**

**PART 2 LOW INCOME EXEMPTION (MEASURE G AND MEASURE N)**

To qualify for the **Low Income Exemption**, you must: 1) own and occupy your property as your primary residence; **and**, 2) the combined family income (from all sources for the 2015 calendar year: January 1, 2015 – December 31, 2015) was at or below the income level qualifying as “very low income” for a family of such size under Section 8 of the U.S. Housing Act. Complete this section only if you qualify for the Low Income Exemption. If you do not qualify for the Low Income Exemption, go to Part 3.

**PART 3 SENIOR CITIZEN EXEMPTION (MEASURE N ONLY)**

To qualify for the **Senior Citizen Exemption**, you must: 1) be 65 years of age or older on or before June 30, 2016; **and**, 2) own and occupy your property as your primary residence. Complete this section only if you qualify for the Senior Citizen Exemption. **If you qualified in 2015-16, you do not have to submit proof of age** - the Property Tax Statement (Part 1) is sufficient. If you do not qualify for the Senior Citizen Exemption, go to Part 4. New applicants must submit proof of age.

**PART 4 VERIFICATION**
