

# Student Safety and Sexual Harassment

## Title IX Reporting

Oakland Tech works closely with OUSD to address reports of sexual discrimination, sexual harassment, or sexual harm. Title IX is the federal law that protects students from discrimination and sexual misconduct, and California has similar laws. ## HOW TO FILE A COMPLAINT

Individuals who believe they have been discriminated against in violation of Title IX may file a complaint with the District or the Office for Civil Rights (OCR). If a crime is involved, such as sexual assault, individuals may also file a report with the local police department. A person may pursue one or all of these avenues at the same time.



## District Complaint

Sexual Harassment

Title IX complaints may be filed using the District's Board Policy and Administrative Regulation 5145.7(a)- Sexual Harassment Complaint Procedures.

A sexual harassment complaint may be filed with the school site principal or his/her designee or a teacher at the school site.

If the individual feels uncomfortable, the complaint may be filed with the Title IX Coordinator, Office of the Ombudsperson.

Complaints may also be made verbally.
